

Specialists Industrial Action

Where a specialist is declining a request for assistance it should be made clear to the person NSW POLICE WILL NOT BE ATTENDING OR ACTIONING THE INFORMATION/REQUEST.

You should refer them the call 131 AFP (131 237) for advice and assistance.

You should record words similar to "The information/request was assessed. There is no immediate risk to the life or physical/psychological welfare of a person. The matter is properly dealt with by a Commonwealth Agency. The informant has been referred to 131 237 for assistance from the AFP."
